### **TEXTURE, TYPE & COLOUR**

The decorative brickwork (inside and/or outside face) is made with a solid unsanded moulded brick without grain with a very uneven structure. Due to the natural reduction with coal the bricks have a strong fired rough field fire aspect. Some visible sides of the brick also contain traces of coal and of the manual production method. The colour of the body is predominantly grey.

## **RAW MATERIAL & PRODUCTION & VIEWS**

This entirely natural product is made of alluvial clay from the Quaternary from the Scheldt valley. The brick is formed in a unsanded mould by putting in a lump of clay and is fired at at least 1150 °C. The facing brick is a solid moulded brick and has a homogeneous structure. It is free from lime and other inclusions and has at least one stretch and one head which are free from cracks and other aspects which negatively affect the overall appearance of the brickwork.

The following are considered defects; the presence of hard spots which may swell and cause the brick surface to flake, cracks with a width > or = 0.2 mm that affect at least 2 edges. Any damage or defects must always be reported before use

## TREATMENT COUNCIL

During processing the bricks should be mixed from 5 different packs. The bricks are stacked tower by tower. The right mortar composition must be determined in consultation with the mortar supplier. Fresh brickwork should always be protected.
